The Surveyor reported that there had been an encroachment on the road, and that the bye-laws should be observed. Mr. Payne, of the Fochriw deputation, said that the fact that a certificate of habitation was withheld for these houses was a hardship, as the owners were only working men. There was much overcrowding which caused them to build the houses, and they had come to urge the Council to grant the certificates of habitation, since many had given notice to leave their present homes, and such notices were about to terminate. A second member of the deputation, Mr. Davies, said that in his house there were only three rooms wherein six persons slept. His elder girl had to sleep out. Mr. Payne stated that the members of the building club were not responsible for the encroachment. The Clerk stated that the Council's remedy was to prosecute for a breach of the bye-laws, but they could not withhold the certificate of habitation. Council members were divided on the action necessary, five supporting a resolution to enforce the bye-laws, and seven supporting a proposal that the Council take no action in the matter. It was decided that the matter should go before the Local Government Board.

26 May 1962 Pantywaun To Be Demolished The village of Pantywaun, near Dowlais, is to be demolished. On Tuesday, Gelligaer Urban Council made demolition orders in respect of the 21 remaining houses in the village. They are inhabited by about 80 people. The village, isolated on a vast expanse of moorland above the Deri Valley was labelled with a death tag earlier this year. This gave rise to a storm of protest from the villagers, who presented a petition to Caerphilly and Gelligaer Education Executives as an objection to the closing of the local primary school. At Tuesday's meeting, four of the villagers were invited to give their views before the Clerk, Mr. D.W.C. Morgan, said that the houses were unfit for human habitation, and incapable of being repaired at a reasonable expense. Mr. Morgan said the residents of the village would be offered alternative accommodation, probably at the neighbouring village of Fochriw. One of the residents, Mrs. Catherine Gallier, told the meeting: "We know the houses, in most cases, are not fit to live in. It's going to cost a lot to repair my house. I am a widow and I cannot afford the expense." The other residents said they were in the same position. The Clerk said there was a provision under the Housing Act for compensation to be paid to an owner or a tenant where it was considered the property had been well maintained. He said that a number of the villagers had already been to the Council office to sign application forms for compensation. Following the Clerk's observations, the four villagers left the chamber to sign application forms for compensation. Coun. Hopkin Lewis told members: "I feel in the long run, the villagers will realise we have done them a service by making the closing orders." Coun. W.H. Bennett said the people would be given better opportunities and a better outlook when they moved into their new homes. We can say Pantywaun is a village that has died. It is not a village that lends itself to development. When the people move, the children will be much better off." Coun. W.J. Payne told members he could remember Pantywaun as a village without electric light, water, telephones, or a railway station. "Now they have all these things, but the houses have deteriorated. I blame some of the owners for this," he said. "I am sorry they have to move, but when they do, they will realise the benefits of the surroundings we have to offer them."

21 July 1962 Fochriw House Owners Can Buy Freehold Leaseholders living in more than 100 homes at Fochriw are taaking steps to buy up the land on which their properties stand.

The action will prevent the leases expiring in two years' time. This was revealed on Monday, when Mr. Ness Edwards, M.P. for Caerphilly, spoke in favour of the residents' plan to safeguard their properties. He told a reporter that he was not without hope that the freeholds could be bought on terms that, in these days, would not necessarily be unreasonable. He said the head lease in respect of the properties, previously held by Guest, Keen and Nettlefolds, has been held by the N.C.B. since nationalisation. The head lease would expire in 1965 and the freeholds would revert to Caeglas Estate. He had had discussions with the N.C.B. and the trustees of the estate, and had put forward suggestions that the sub-lease be commuted so that direct negotiations could take place between the owners of the houses and the estate.

The meeting was called to discuss the possible purchase of the freeholds of the Caeglas property involved. There are about 100 leases, which have only a short time to run. Mr. Edwards invited statements from those present at the meeting who had made application for their freeholds. Coun. Hopkin Lewis also spoke on the matter. Thanks were accorded to Mr. Edwards for his efforts. Mr. John Ballard was elected secretary, to collect the necessary information concerning the purchase of the freeholds. A further meeting is to be called in the near future.

4 August 1962 Only The Public House Will Be Left In Pantywaun The Royal Arms Hotel, built in the last century to serve the isolated village of Pantywaun, is likely to be a public house without customers when the rest of the village is demolished by Gelligaer Urban Council. The hotel, owned by the Rhymney Brewery Company, is the only building in the village that has not been served with a demolition order. When the 80 residents move from the village, trade at the pub will collapse and the building will be forced with closure. Already, the hotel is losing custom and stocks of beer have been cut down. The licensee, Mrs. Elsie Evans, who lives at the hotel with her husband, Mr. John Thomas Evans, told an Express reporter: "Our customers have drifted away and business has been on the slack side for weeks. During the past month, we have sold hardly any beer. Two of three men call occasionally for a few bottles, but that is all. On Saturday night, we had two customers, and from now on things well get worse," she commented. Mrs. Evans, who is the mother of six sons, four of them schoolboys, said they had no plans for the future if the pub is closed. "I have been to the Council and they asked me to apply in writing for a house. But I have heard nothing yet," she added. A spokesman for the Brewery said on Thursday: "We would like to keep the pub alive, but there is no future for it. We have made no definite plans as yet, but if the other houses are demolished, there is no way of keeping it alive. It's a pity but the building is in reasonably good condition, but the drainage facilities there are not adequate," he added. The spokesman stated that there was no bulk stock of beer at the hotel because trade had become generally poor. He said the licensee normally called at the brewery with a van when supplies were low. Demolition orders in respect of the 21 houses in the village were made by Gelligaer Urban Council on May 22.

8 September 1962 Fochriw Householders Offered Freeholds One hundred leaseholders at Fochriw are to be given the chance to buy the freeholds. Mr. Ness Edwards, M.P. for Caerphilly, gave the news at the weekend. He said the arrangements had been made whereby the Coal Board would surrender the head lease on the properties, thus enabling the Caeglas Estate to offer the freeholds to the owner-occupiers. The leases are due to expire in two years time. About two years ago, a like number of leases were sold to the owner-occupiers by the same ground landlords on terms said to be reasonable and fair, having regard to present-day conditions. Mr. Edwards said he was satisfied with the way matters were going. Coun. W.J. Payne presided at a meeting at Fochriw last week, when those present accepted a suggestion that steps to be taken in the present negotiations should follow those adopted when the previous ground rents were bought.

8 September 1962 <u>Leaseholders</u> Coun. Payne presided over a meeting at the New Hall on Wednesday evening of the Ceaglas Fochriw Leaseholders. Mr. Ness Edwards, M.P., gave a detailed report of progress since the last meeting. He had dealt with the N.C.B. and the solicitors of the Estate, and the outcome was very satisfactory. He said that Coun. Payne

would deal with matters as they arose, and when necessary, a further meeting would be called. Mr. Edwards, Coun. Payne and Mr. John Ballard were thanked by the leaseholders for the work they had done. Coun. Hopkin Lewis was present and spoke.
