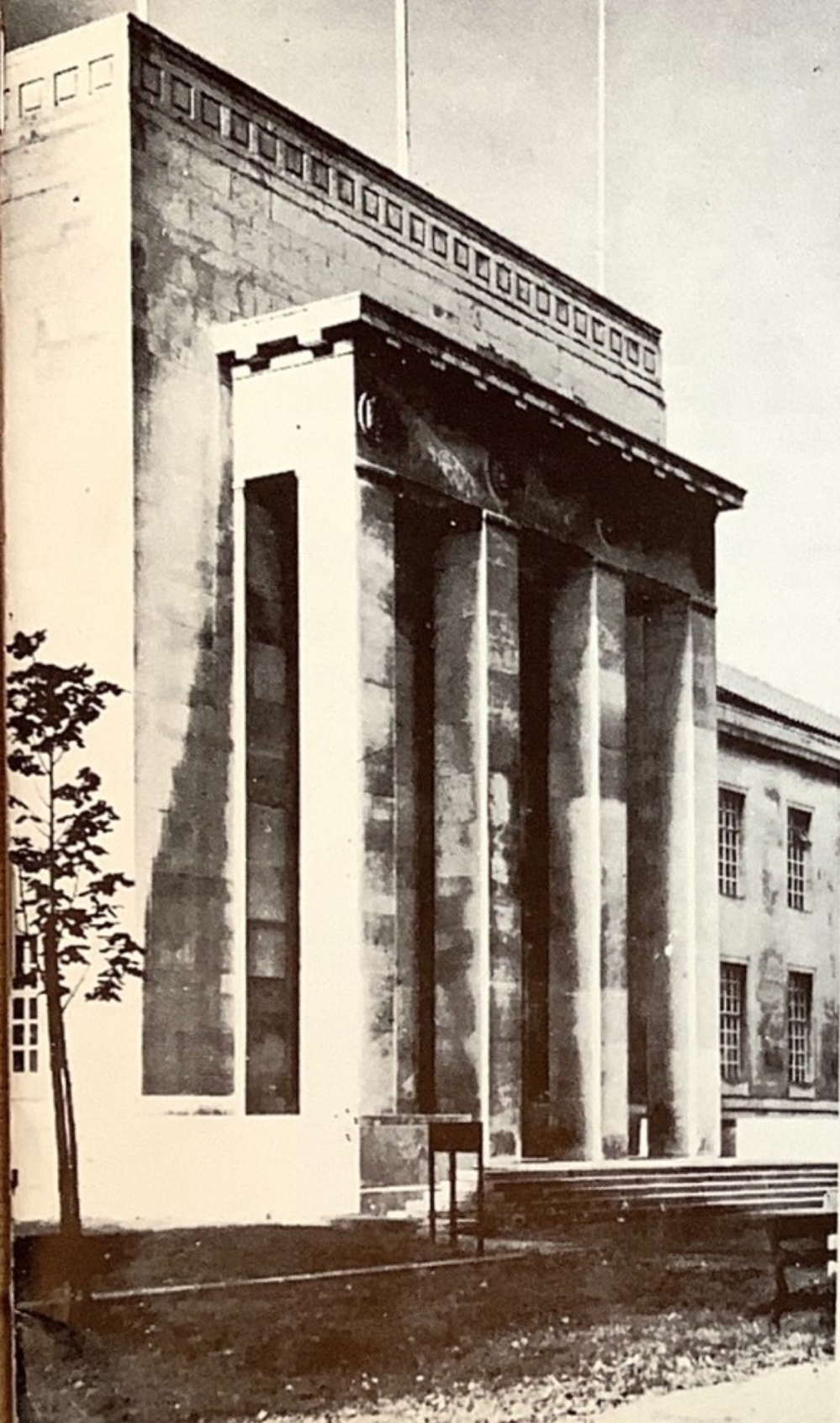

## President's Foreword

## Rhagair y Llywydd

Once again the Centre has endeavoured to provide for Wales a window on the world's major events. The Brandt Report, of which over 117,000 copies have been sold in the United Kingdom alone, was the theme of six Conferences in different parts of Wales. Our Anniversary Meeting dealt with Nuclear Weapons in Europe, whilst both these issues have been discussed in the two most recent Special Papers of the Welsh Centre.

Links continue to grow with international organisations, exemplified by the Conference on Human Rights in conjunction with the Council of Europe and the contract with UNESCO.

Unfortunately, it is difficult to say that the world is a better place than it was a year ago. The recession and the resultant world unemployment, the spiralling cost of armaments, the increasing gap between poor and rich, conflict in the Middle East, in Afghanistan and other world flashpoints - all this makes it even more essential that the Centre should be properly equipped in an interdependent world to help to maintain Wales's traditional concern for international peace and understanding.



## Message from the Director of the International Labour Office for Great Britain and Northern Ireland

The Third Development Decade of the United Nations has opened in a sombre atmosphere with the existing system of international trade and international finance under critical review by the Group of 77 in their search for a New International Economic Order. Now, the daunting issues of widespread unemployment and poverty in the world have been defined in a dramatic report prepared by a distinguished Independent Commission on International Development under the Chairmanship of Willy Brandt. These two powerful influences on the relations between North and South have provided the stimulus for the summit meeting in Mexico in October 1981 of 22 Heads of State. Nothing could underline more the interdependence of the countries of North and South and the need to find the massive resources that are needed merely to contain, let alone reduce, the rising tide of abject poverty which at present afflicts more than 700 million people. It is a programme for survival which is being sought: "Jobs for the next generation - a decent standard of living (in the industrialised countries) will depend to a higher degree than we have imagined on the development of the Third World".

The vital task of the nations of the world is to work together to free mankind from hunger and distress, dependence and oppression. These aims cannot be achieved in a single generation - and certainly they cannot be achieved without a strong public awareness of the issues involved since in the long run they will involve sacrifices of one degree or another on the part of the richer countries.

The Welsh Centre for International Affairs fulfils a unique and essential role in creating this public debate and mobilising enlightened public support.

**The Seventh Anniversary**

The guest speaker at the Seventh Anniversary Meeting which took place at the Temple of Peace on the 17 October was Field Marshal Lord Carver, former Chief of Defence Staff.

Lord Carver's subject was "Nuclear Weapons in Europe". After a wide-ranging address which related the subject to the security of Europe and to nuclear weapons world-wide, Lord Carver concluded:

"What I believe we should aim at is a stable military balance, reflecting a stable political balance, between the Western world and the Soviet bloc. That balance, if it is to keep us secure, must be at a high enough level to deter nations from going to war. It must include nuclear weapons; but it need not, and it should not include them in the ridiculously and dangerously large numbers that it now does. It could be at a very much lower level. All our efforts should be bent, first, towards establishing a stable balance at the existing level; then to reducing it, while keeping it stable. If, in that process we can contribute to its success by giving up our own nuclear weapons, I would favour that; but, at present, it would not help progress, perhaps indeed hinder it. Progress will demand infinite patience, clear vision and a degree of dispassionate acceptance of unpleasant realities that it is rare to find in any body of men and women, political or other. I hope that this Centre will play its part in helping to achieve that.

The meeting, which attracted an audience of over 350, was chaired by the President of the Welsh Centre, Hon. Edward Davies. Civic welcomes were given by Councillor Phillip Dunleavy, Deputy Lord Mayor of Cardiff and the Chairman of the South Glamorgan County Council, Mrs. Bella Brown.

**Lord Goronwy-Roberts**

It was with very deep regret that members learned of the death of the President of the Welsh National Council of the UN Association, Lord Goronwy-Roberts, on July 24.

Lord Goronwy-Roberts had had a long and distinguished political career in Parliament, serving as Member for Caernarvon for 29 years before being elevated to the peerage in 1974. He served as Minister of State for Wales, for Education and for Foreign and Commonwealth Affairs, and as Deputy Leader of the House of Lords.

Lord Goronwy-Roberts will be sadly missed.

Oil Ltd., London, on "The OPEC Dimension". The Principal of the Normal College, Dr. J.A. Davies, was the Chairman. Some 60 delegates attended, representing all walks of life in the county.

The Director of the United Kingdom Committee of the United Nations Children's Fund (UNICEF), Mr. Robert Smith, visited the Welsh Centre.

**v) United Nations Day - October 24**

A bi-lingual leaflet was produced by the Central Office of Information with the Welsh Centre being the point of contact for people in Wales. It emphasised that "Man has the fundamental right to freedom, equality and adequate conditions of life, in an environment of a quality that permits a life of dignity and well-being".

**vii) The European Convention on Human Rights - Temple of Peace, November 17 (In conjunction with the Council of Europe)**

Over 100 delegates representing a wide range of interests, including the law, local authorities, the medical profession, industry, the unions, the health service, the police, the University and Polytechnic of Wales and a wide range of voluntary organisations attended the conference.

The speakers included the former Lord Chancellor, Lord Elwyn-Jones, Mr. Giuseppe Guaneri, Principal Administrator in the Directorate of Human Rights, Strasbourg, on "The Council of Europe and the European Convention on Human Rights", Mr. Herbert Petzold, Deputy Registrar of the European Court of Human Rights, "The European Commission and Court of Human Rights", and Dr. Alpha Connelly, Dept. of Law, University College, Cardiff "The Implementation of the Convention in the United Kingdom including some recent cases of interest before the Commission and Court". The Chairman was Judge David Williams, QC.

The Planning Committee for the Conference has been reconstituted as an ongoing committee (for legal affairs) of the Centre. At a gathering of the delegates on Human Rights Day, December 10, it was agreed that the Committee should consider an appropriate follow-up to the Conference.

The workcamp programme attracted good press coverage. Receptions were held to allow the volunteers to meet local authority leaders and representatives of the local community.

In addition more than 70 volunteers from the United Kingdom were sent to workcamps in Bulgaria, Canada, Czechoslovakia, Denmark, Finland, France, Germany, Holland, Hungary, Morocco, Poland, Spain, Switzerland, and Turkey.

On June 10-11 the UNA (Wales) International Service Committee hosted a meeting of the United Kingdom Workcamp Organisers' Co-ordinating Committee (WOCC), the first time such a meeting has been held in Wales. On June 11 the Committee visited Brynmawr (Gwent) on the occasion of the 50th Anniversary of the first international workcamp in Britain, held there in 1931.



## Financial Appeal

At the 1979 Annual Meeting, grave concern was expressed for the financial security of the Welsh Centre. It was pointed out that the proportion of *assured* annual income was so small in relation to annual expenditure, that an undue proportion of staff time had to be spent in fund-raising at the expense of furthering the objectives of the Centre itself. The lack of security has led to a fairly rapid staff turnover which has caused considerable working difficulties in an organisation as small as the Centre.

As a result, a Sub-Committee to raise funds was set up under the Chairmanship of Mr. Christopher Pollard with Mr. Gerry McMorran as Hon. Project Director. The aim is to achieve a capital base of £250,000 to produce an income at a level which would help secure more soundly the work of the Centre during the 80's. To date, some £60,000 has been raised, including grossed-up covenants.

1983 will mark the Tenth Anniversary of the Welsh Centre's opening and a major effort will be undertaken to raise these funds by the end of that special year.

All associated with the Centre and its Committees are strongly urged to do their utmost to seek support for the fund.

## Finance

Excluding special designated funds of £1474, £116,030 was held in the UNA (Wales) Trust at the close of its financial year on December 31, 1980. Interest of some £14,000 helped to meet some of the core costs of the Centre so far as its charitable activities were concerned. While such reserves may seem at first sight healthy, the interest represents virtually all the assured income that the Trust has. If grants which are usually made on an annual basis were to cease, the lack of such reserves would mean the dismemberment of the Centre.

Each Member Organisation of the Co-ordinating Committee makes a contribution of £25 annually to the Welsh Centre for International Affairs' account, which at 31 August, 1981 stood at £720 after a loan of £5,000 to the UNA (Wales) Trust. A proportion of the costs of the Annual Report was met from this account. For information there is appended a summary of the Trust Accounts.

## LEGACIES

In 1976 we received our first legacy and it may accordingly be appropriate to remind members of the 1972 Finance Act. This Act made valuable concessions to charities and gifts of property to charities exempt from Capital Gains Tax. The 1975 Finance Act excludes from Capital Transfer Tax gifts to charities up to certain limits. Important provisions were made in the year's Budget in favour of charities. The limit of exemption for bequests from Capital Transfer Tax was increased to £20,000. The gift may be made in the lifetime of the donor, or in his or her will. Anyone kindly minded to benefit the Trust in this way should seek the advice of his or her solicitor on the substantial benefits involved.

## COVENANTS

The Finance Act 1980 made new provisions with regard to gifts to charities in the form of a deed of covenant. Under the new provisions payments made on or after 6 April 1980 will rank for tax relief, providing the commitment under the deed is capable of exceeding a period of three years. Furthermore individuals can, in addition to receiving income tax relief at the basic rate of 30%, obtain relief at higher rates of income tax which they may be paying and the investment income surcharge in respect of payments made on or after 6 April 1981. The amount relieved against the higher rates of income tax and investment income surcharge is limited to a maximum of £3,000 per annum. Your accountant would clarify any difficulties.

## UN International Year of Disabled People 1981

The U.N. General Assembly proclaimed 1981 as the I.Y.D.P. and called for a world plan of action to help the 500 million disabled people in the world. One of the five main objectives of the year was to promote effective measures for the prevention of disability. Consequently, UNICEF had a particular role to play. The Welsh Centre was asked to co-ordinate a fund-raising campaign in Wales for the 'Silent Emergency' in the Sudan, where there are seven and a half million children, of whom 1 in 4 will not live to see his first birthday. Sudan was chosen because it is one of the poorest countries in the world. In addition to UNICEF, the World Health Organisation, Food and Agricultural Organisation and the International Labour Organisation are making concentrated efforts to improve the quality of life there.

As a contribution to the International Year the Centre agreed to raise £60,000 for UNICEF's work. The Mayors and Chairmen of 29 of the principality's Borough and District Councils pledged their respective areas to co-ordinate and promote local fund-raising efforts. At the half year point it was encouraging to find that some £10,000 had been received from a variety of sources. The Campaign is scheduled to last until March 31, 1982.

### The Advisory Committee for Development Education and Information

The Committee covered the following during the 1980-1 session: Primary, Secondary and Tertiary education, the follow-up to the Brandt Report, preparations for the first World Food Day Conference, development resource centres, eisteddfods, links with local authorities and the media.

### Special Papers

In 1980 the Welsh Centre published Special Paper 8, "The Prevention of War in Europe", by its Research Consultant, Goronwy J. Jones.

"The main theme of this paper is that in order to prevent war with the Warsaw Pact powers in Europe, the only realistic approach is for Britain and her NATO allies to continue their efforts to maintain the balance of power in the region, whilst seeking to reach verifiable arms control and disarmament agreements with the Warsaw Pact powers that would enable the balance of power to be achieved at lower levels of armaments and military forces. East-West tension should diminish as weapons decrease.

armaments and military forces. East-West tension should diminish as weapons decrease.

In order to justify the importance of maintaining this balance of power in Europe, the attention of the reader is first drawn to the lessons that we should have learnt from the two major wars, which caused such an enormous loss of life and devastation in this century, then to the successful efforts that NATO has made since its formation in 1949 in maintaining the balance of power and thus the prevention of war in Europe.

This is followed by an account of the obstacles to East-West agreements on arms control and disarmament agreements, with suggestions as to how they might gradually be overcome. Finally, the main features of the Thatcher Government's defence policy, as well as the views of some of its critics, are discussed."

### **Contract With UNESCO**

The Welsh Centre concluded in 1981 a contract with UNESCO to associate UNESCO with the Centre's Conferences on issues of particular importance to

UNESCO such as world peace and development. This has so far involved the Conferences on the Brandt Report in Swansea and Colwyn Bay

This is the latest in the growing series of links the Centre has established with international organisations in the eight years of its existence including the U.N., the World Bank, UNICEF, the Commonwealth Secretariat, the E.E.C., and the European Court and Commission of Human Rights.

### **Certificate of Merit**

The Welsh Centre was awarded a Certificate of Merit by the United Kingdom U.N. Association for its use of the media to further international justice and peace.

The Certificate was presented to the Director, Mr. W.R. Davies, by the Editor-in-Chief of the Observer, Dr. Conor Cruise O'Brien in London on March 11.

### **The United Kingdom Freedom from Hunger Campaign**

The Committee administered from the Welsh Centre is supporting four main projects, two in India, one with the Bihar State Dairy Corporation, to set up a dairy in Muzaffarpur (£317,000) and the other a cattle improvement scheme with the Pradesh Dairy Co-operative Federation, Uttar Pradesh, (£118,000), one in Malawi to develop a Nutrition Trading Unit at Bunda College (£86,000); water-drilling with Family Farms, Zambia (£51,000).

Grants have been given in 1980/81 to support two V.S.O. workers in Kenya and Thailand (£1,200) to the Zimbabwe F.F.H.C. (£609), to the Wales (U.N.I.C.E.F.) project for I.Y.D.P. in the Sudan £2,000.

## Reports of Organisations Represented on the Co-ordinating Committee

The Organisations represented on the Co-ordinating Committee have made important contributions to the activities of the Welsh Centre. But it has not been felt necessary to refer to them specifically in each case. Summaries of their Reports are set out below. Copies of the Reports are available on request.

### (a) UNITED NATIONS ASSOCIATION, WELSH NATIONAL COUNCIL

**Annual General Meeting.** The 35th AGM was held at the Temple of Peace on April 25th. Lord Goronwy-Roberts was unanimously re-elected President and Mr. Ray Palmer, Hon. Treasurer. At a subsequent meeting of the National Council, the following were elected to the Executive Committee for 1981-4; Mr. G. Brace, Mr. J. Burford, Mr. H.V. Davies, Mr. K. James, Dr. T.P. Jones, Dr. Rosa Morris, Mr. G. Slade, Mr. J. Davidson, Mr. Dale Owen and Mr. Alun Rowlands. At a subsequent meeting of the Executive Committee, Mr. Goronwy J. Jones was unanimously re-elected Chairman.

**Future of United Nations Association.** It was agreed that for an experimental period of one year, UNA should concentrate on its role as a non-party, political pressure organisation. Any new local groups should be based on constituency boundaries and maintain regular contact on policy issues with their MP., MEP., and prospective candidates.

**Policy Developments.** Issues discussed during the year included International Development Strategy, Detente, Disarmament and Deterrence, Disaster and Relief Organisations, Nuclear Disarmament, EEC and the Palestinian Question, Northern Ireland, EL Salvador and the Israeli attack on Iraq.

**Obituary.** Members were saddened by the death of Mrs Cynthia Roper (late of Pontypool). and of Lord Goronwy-Roberts.

**Congratulations.** Members were delighted by the award of an Honorary M.A. by the University of Wales to Mr. Alwyn Evans (Swansea).

**Membership.** At the close of 1980 there was a membership of 780, a decrease of 77 on 1979. It was agreed that a flat rate of £6 per annum be adopted.

**Woman's Advisory Council.** The Council held its usual quarterly meetings.

Speakers included: October 4, Dr. Patricia Howell, Radiation Biologist, 'Nuclear Power and the Public', February 7, Mrs B. Bradby, Chairman, Women's Advisory Council, UNA of Great Britain and Northern Ireland, 'UN Mid-Decade Conference for Women', May 2, Mr. J. Homewood, Secretary S. Glamorgan, IYDP, 'IYDP 1981', July 4, Mr. Elfed Jones, Oxfam, 'The Brandt Report'.

At the Annual General Meeting on May 2nd the following offices were elected: Chairman, Mrs. M. Bold; Vice-Chairman, Mrs G.C. Evans; Secretary, Mrs. V.L. Smith.

**United Kingdom General Council - London, April 3rd-5th.** The Chairman of the Executive Committee, Mr. Goronwy Jones and the Secretary, Mr. W.R. Davies represented UNA Wales at the UK Annual Meeting at Goldsmiths College, London. A wide range of resolutions were discussed: Afghanistan, Bolivia, Central America,

Chemical and Biological Weapons, Disarmament, Kampuchea, the Middle East, Namibia, Nuclear War, Proliferation and Nuclear Energy, Political Misuse of UN Agencies, Revision of the UN Charter, the Brandt Report, Codes of Marketing, Security and Co-operation in Europe, Development Education, Arms Sales to Third World Countries, Human Rights, Incitement to Racism and Religious Hatred, the International Monetary System, International Seed Library, Law of the Sea, the Media, Citizenship and Dependent Territories, Persecution of the Jews in Soviet Union, Preservation of World Forests, the Status of Women, Year of Disabled People and the Work of the UN Disaster and Relief Organisation.

The problems of the Middle East had been discussed at length at the 1980 Annual Meeting in Edinburgh following which a Special Commission was set up under the Chairmanship of Mr. Malcolm Pill, QC, a former Chairman of the Welsh Executive Committee. The recommendations of the Commission were approved by the AGM.

### (b) COUNCIL FOR EDUCATION IN WORLD CITIZENSHIP - CYMRU.

**Annual General Meeting.** At the A.G.M. on May 16, 1981, the following Officers were unanimously re-elected: President, Dr. A.B. Oldfield-Davies; Vice-Presidents, Sir Alfred Nicholas, Miss M.M. **Annual National Residential Sixth Form Conference.** The Sixth Form Conference, held at Atlantic College, St. Donats, from 10 - 14 April, was the main event of the year.

some 50 sixth formers from every part of Wales. They were joined by Atlantic College Students. The theme proved to be popular and the participants found the sections on Japan and China especially interesting. Miss Elizabeth Wright, Director of GB-China Centre, Miss K. Shimoda, the Japanese Embassy and Mr. Richard Tames of the School of Oriental and African Studies also participated.

Mr. Christopher Laidlaw, Assistant Director of the Commonwealth Secretariat, was the inaugural speaker. Mr. Laidlaw spoke about the economic trends in the Pacific, particularly in relation to its emergence on the world market. Other speakers made valuable contributions, Dr. Tony Hopkin of University College Cardiff and Mr. Eirwyn Thomas, HMI, being particularly helpful.

**International Year of the Disabled (IYDP) 1981.** The Sudan UNICEF appeal was launched in schools as CEWC's effort towards this special year. A fund-raising target of £15,000 was set, which matched that for the Year of the Child.

**Curriculum Development - Development Education: Mode II 'O' Level Syllabus.** The final acceptance of the 'O' Level course was delayed while the re-organisation of the national examination took place by the W.J.E.C. The response from schools was very good. Over 35 schools expressed interest in taking up the course as soon as possible. The Assistant Secretary is maintaining links with these schools so that appropriate steps can be taken when the future of the 'O' Level is known.

**Junior Project in conjunction with UNICEF:** The Assistant Secretary has been working closely with the Education Officer of UNICEF, Mrs. M. Yerrell, to introduce development education in Primary Schools in Wales. The Assistant Secretary

publicised the UNICEF teaching packs on Water, Food and Blindness. The response was good. In addition the Assistant Secretary visited Primary Schools to talk to the pupils on the theme of Water.

**Welsh Language Materials.** In order to extend the range of the project, the teaching packs were also produced in Welsh. This was made possible by two grants, one from UNICEF, the other from the Welsh Office. The UNICEF grant was especially important as it was the first award to be made in Wales by the National Committees for UNICEF in Europe from the Mutual Assistance Fund. The help from both UNICEF and the Welsh Office enabled CEWC to make valuable headway in the provision of Welsh language material.

**Seminar on International Understanding in the Welsh Context - Nov 14.** An important seminar on the teaching of development education and international understanding was organised by the Assistant Secretary on November 14. Over 60 delegates attended, representing the Education Advisory Service, the Inspectorate, school and college teaching staff and students of education. The session was opened by Mr. Ted O'Connor of the School of Oriental and African Studies, the Chairman of the Standing Conference on Education for International Understanding (SCEIU). Case studies for the Primary, Secondary and Tertiary sectors were given, and Baroness Young, Minister of State for Education, presented the Government's view point. The Seminar was held at the Welsh Centre.

**Schools Competitions.** Following the success of the IYC Primary Schools Competition, the Assistant Secretary organised a similar event this year, kindly sponsored again by Drake Educational Associates. The theme of the competition, which drew 168 entries was "Rich Man, Poor Man". Prizes in the form of book tokens were awarded on a county basis. An overall winner was also selected, Susan Harris of Hopkinstown, Pontypridd.

A pioneering Secondary School Competition was organised with the help of Mr. William Davies of Cwmbarn. Mr. Davies, a long-standing member of UNA, generously donated £700 for a competition which would be held in memory of his late wife, Sallie. A further donation enabled CEWC to offer prizes of £100, £50 and £25. The initial competition will be an essay on "The man or woman, living today, who has made the greatest contribution to world peace".

**Other Events.** The Assistant Secretary has continued to visit member schools in all parts of Wales, maintaining valuable personal links. A wide variety of school events took place throughout the year. These included four sixth-form Conferences on the Security Question at Swansea, Cwmbarn, Mold and Porthcawl. Over 50 schools were involved.

The Brandt Report was the subject of a Seminar at Caernarfon and a second conference at Mold while similar development issues were debated by fifth formers at Pontllanfraith. Neighbouring schools participated in each. The S. Glamorgan events, the 5th Form UN Debate and the Donald Miller Public Speaking Competition were successful, as was the T. Jacob Jones Speaking Competition at Ogwr. The children's Christmas Party, organised by the Cardiff UNA and Voluntary Community Service, was again assisted by willing Sixth Formers of member schools. The Assistant Secretary also attended the 19th Annual Residential Conference for Students in Industry at Aberystwyth in September.

**Obituary:** Members were deeply saddened to learn of the death of Mrs. Lilian Oldfield-Davies, wife of the President, Dr. A.B. Oldfield-Davies in Cardiff on July 22.

The total amount raised by the Welsh Committee of the Freedom From Hunger Campaign since its inception approaches £600,000.
