

The will of John Lloyd of Cowbridge, dated 28th., May 1672.

To be buried in his parish church of Cowbridge.

His house in Cowbridge, purchased from William Williams of Llantwit Major, gent, to his wife, Alice during her widowhood and then to his son John Lloyd.

To his son Thomas Lloyd, a feather bed with bedstead, curtains and vallions, feather bolster and all other bed clothes in the chamber over the parlour after his mother's widowhood; and the table and frame also in that chamber.

The rest of his household property to his wife during her widowhood and thence to his son John Lloyd.

All other property to his wife Alice as executrix charged with the upkeep of their sons.

In the Name of God Amen I John Lloyd of the Towne of Cowbridge in the County
of Glamorgan, and whoe the Decretts of Llandaph, being sick in body but of sound and
perfect memory. laud and praise be to Almighty God, And for that I have ad vnto
to settle and dispose of that little Estate which Almighty God hath bene pleased to bestow
vnto me withall for the good and benefit of my wife and children, do make and ordeyne
this present writing to be my last will and Testament in manner and forme following
I recommende my soule and bequeath my soule into the hands of Almighty God my Maker
trusting only in and through the Meritts of Iesus Christ my Saviour to have the
forgiveness of all my sinnes and life Eternal; And my body to be buried in my
parish Church of Cowbridge. I doe give devise and bequeath
vnto Mye my wife, my house in Cowbridge that I dwelle in together
with the Curtilage & garden thereto belonging during her
widow Estate only, and from thenceforth I give devise and bequeath
my said dwelling house Curtilage and garden with all other
appurtenances in as large a manner as I purchaseth the same from
or as I bought the said house from William Williams of Cantwilt Maids
in the said County of Glamorgan, I give devise and bequeath the said house,
vnto my son John Lloyd and to his heirs and assigns forever
I doe give and bequeath vnto my son Thomas Lloyd one feather bed
with the bedstead Curtaine and vallies foaldr bolster wth all other
bed clothes belonging to the same as they now are in the Chamber
over the parlour as to her widow Estate and the table and frame in
the said Chamber; I doe give and bequeath all the rest of my goods
shuttles and household stuffe vnto Mye my said wife during
her widow Estate, and from thenceforth vnto John Lloyd my son I give
and bequeath all my said goods and household stuffe, so for all other my goods
shuttles and debts her residue I bequeath to wholly give and bequeath
vnto the said Mye my loving wife whom I doe nominate sole executrix
of this my last will and Testament and shee geve my said executrix
with the maintenance of my both children Thomas Lloyd and John Lloyd

of May in the fourth and twentieth year of the reign of our Soveraign Lord
King Charles the first, and in the year of our Lord god 1672
