- 1913, 31st July The Dunraven estate (the Earl of Dunraven) conveyed to Canon Thomas Llewellyn Lister of St Mark's Vicarage, Newport, Gwent – the garden of No. 9 and No. 11 Westgate (the piece of ground on which was erected the rear portion of the dwelling house, and the adjacent dwelling house), now in the occupation of the purchaser Aberthin 159, NLW
- 1919, 15th September Canon T. Llewellyn Lister of Newport sold 11 Westgate to Rachel Thomas, widow of 11 Westgate
- 1923, MarchRachel Thomas sold to William John Thomas and his wife Rosa
Mary of Brynblodau, Aberthin, post office clerk
- 1923, May William Jenkins of 3 The Butts sold to WJ Thomas – land adjoining the eastern part of a garden, commonly called the Bear Garden (17ft 622 x 129ft 2")
- 1925 William Jenkins sold to WJ Thomas the adjoining eastern part, being the continuation south to north (17ft 6" x 95ft 2")
- 1942 WJ Thomas, postmaster of Cowbridge post office, sold to Frederick P Roberts, retired station master of 11 Westgate the house and adjacent garden

Mervyn and Dorothy Evans lived in 11 Westgate during WW2 and until the 1950s – he was a member of the Ducal Drinkers. They had a son John and a daughter. Leicester Brown the dentist had a surgery in the left-hand front room. *Memories of Tim Edwards*
