Kingscombe Farm, Llanblethian

History

Early C19. On Tithe Map.

Exterior

Two storeys, 3 windows. Double-pile plan. Stucco over local stone (exposed to rear), shallow pitch slate roof, rendered chimneys. Entrance faces S; on first floor, three 12-pane hornless sash windows. On ground floor, 2 similar windows flank central doorway with overlight and intersecting glazing, panelled reveals, panelled door, modem Doric porch. To R, lower extension, 2 storeys, one 6-pane sash window to each floor.

Listed

Early C19 house, retaining most of its character, in conservation area.

Although known as Kingscombe Farm this property, as described in the Tithe Schedule of July 1840, consisted only of a House and Garden with an Upper Field and Lower Field (both meadowland) totalling 8 acres 2 roods and 17 perches. It was owned, under the system of copyhold tenure, by William Lewis who had inherited it, together with the farms of Trebettyn and Llanquian ucha (or Hollybush) according to the customs of the manor of Llanblethian - the lord of the manor being the Marquis of Bute. The previous owner of Kingscombe had been David William of Llanblethian who, in 1807, had purchased the property for £974 from Andrew Armstrong of Great House (and previously of Llandough Castle). David William died intestate in 1827 and without ever having married (1) and 24 year old William Lewis, born in Llanblethian, was the heir according to the custom of the manor. By 1834 Lewis was married to a Swanseaborn girl, Anne and lived in Llanllwch near Carmarthen town where their first son, John, was born. In 1835 the family was living at Earlswood Cottage, Cadoxton-juxta-Neath where David (1835), twins Catherine and Mary (1837) and Gwilym (1840) were bom and baptised in the parish church (2). William Lewis signed his last will and testament at Earlswood Cottage in 1837, appointing William Lewis, gentleman of Bridgend and Thomas Lewis, ironmonger of Cowbridge as trustees. His wife was to receive an annuity of £40, his two daughters £500 each when they married or reached the age of 21 years and the lands and properties were devised to the two sons, John and David, as tenants in common (3). This will was never amended despite three more children (Gwilym, Jennet and Eliza) being born after 1837. Kingscombe in 1837 was tenanted by John Williams, a surveyor of taxes but at the time of the Tithe Schedule in 1840 it was apparently occupied by William Lewis although his family were probably still living at Cadoxton where Gwilym was baptised in September 1840.(4).

In the 1851 census Kingscombe was empty and William Lewis had moved to Hollybush Farm on Stalling Down, describing himself as a farmer of 104 acres, employing 4 men and he was also a landed proprietor. (5) Four years later he had died at the age of 53 but his widow Anne lived on until 1876 although not at Hollybush. Both were buried in Llanblethian although Anne Lewis died at Newcastle, Bridgend (6). Her tenant at Kingscombe in 1861 was Georgiana Royds, a widow born in Lancashire and a fundholder, as was her daughter Alicia Vittoria Royds. The two ladies were supported by a married couple, Joseph and Jane Strange as domestic servant and cook, and also a housemaid and 13 year-old general servant. Frederic Charles Allin Royds, living at St. Quentins Cottage with his wife, Frances, was possibly Georgiana Royds's son.

In 1871 Kingscombe again appeared to be vacant but by 1881 Arthur Treharne, a retired naval officer and his wife, Harriet, were in occupation at the time that John Lewis of the city of London, ship broker and David Lewis of Briton Ferry, clerk in holy orders, were admitted as tenants in common (7). On the 20 September 1886 Kingscombe was sold by the Lewis brothers for £1180 to William Rees, innkeeper of Graig Ddu Dinas.8 He was living there as a dairy farmer in 1891 with his wife Anne, a niece Bronwen Walters and a maidservant. A small parcel of land (60ft. x 30ft.) on which the Sunday School (later parish hall) was built, had been sold to Llanblethian church in 1888; the rest of the land and the property was conveyed to Thomas Thomas, farmer of Wern fawr in Ystradowen parish, for £1200, in November 1895A David Jenkins and then his son Richard farmed Kingscombe in the early twentieth century. Thomas Thomas died at Penylan House, Capel Llanilterne on the 14th September 1917 His will left his estate in trust to his wife, Elizabeth and after her death to her niece Winifred Elizabeth Philpott9 On the 10th October 193010 Elizabeth Thomas died at Greenfield, Ystradowen, the home of her niece Elizabeth, wife of Howell David Thomas who farmed Greenfield. Kingscombe with its 8 acres and 2 fields of 1 acre and 2 acres near Brynhyfryd on the Llanmihangel Road were conveyed to the younger Elizabeth Thomas on the 31st December 1931.

Last will and testament of **William Lewis** of Earlswood Cottage, Cadoxton-juxta-Neath. He bequeathed unto William Lewis of Bridgend, gent and Thomas Lewis of Cowbridge, ironmonger, all his personal estate; also Llanquian Ucha and Trebetting in the parish of Llanblethian and one messuage and land in the village of Llanblethian on the side of and adjoining the road leading to Llanmihangel in the occupation of John Williams, surveyor of taxes for 500 years from his decease in trust that they should pay out of his person or real estate one annuity of £40 p.a. to his wife Anne for life or as long as she remain a widow. The remainder of the estate to apply profits to maintenance and education of his four children: John, David, Mary and Catherine and invest surplus for the benefit of the children. Two several sums of £500 to be raised to be paid to daughters as soon as they reach the age of 21 or marry with consent. As soon as trusts had been discharged premises should be devised to his sons John and David as tenants in common and not joint tenants.

Signed: 7th April 1837 William Lewis died on the 29th June 1855.

Signed on 4th May 1915 Thomas Thomas died on the 14th September 1917..Probate to widow Elizabeth Thomas of Penylan House. Gross £3924. 7s 4d net £1874 17s 5d.

Grant of Probate 13th December 1930 at Llandaff of last will of Elizabeth Thomas formerly of 66 Corporation Rd, Cardiff who died at Greenfield on 10th October 1930. Probate to William Edward Phillpotts of Pantylladron Farm, near Cowbridge, farmer, nephew of deceased and Thomas Heal Ralls, solicitor's clerk, 52 Eastgate, Cowbridge. Gross £2315 13s lid, net £2224 12s.

Assent 31st December 1931 between Wm Edward Phillpotts of Pantylladron farm and Thomas Heal Ralls of one part and Elizabeth Winifred Thomas of Greenfield, Ystradowen, wife of Howell David Thomas of same place, farmer, the beneficiary. Various pieces of property including Kingscombe 8 acres and fields near Brynhyfryd 1 acre and 2 acres.

Manor of Llanblethian.

15th January 1807 John Miles of Aburthin, gent, feoffee of premises with Andrew Armstrong of parish of Llanblethian, Esq., in consideration of £974 paid to Armstrong by David William of Llanblethian surrendered one customaryhold messuage or dwellinghouse, garden and orchard 2 acres, formerly purchased by Armstrong of David William and one other close or piece of land called Crofta mawr, 4 acres, then lately purchased by Armstrong of the trustees of the will of the late Rev. Thomas Bruce having other lands of the said Armstrong adjoining east highway from Cowbridge to Llanmihangel. John Bevan of Cowbridge, surgeon feoffee in trust to use of David William.

David William died intestate in 1827 without ever having married leaving William Lewis of Earlswood Cottage, Cadoxton his customary heir.

Admittance 30th May 1881 John Lewis of 10 Cullum Street, City of London, ship-

broker and David Lewis of Briton Ferry, clerk in holy orders were admitted to premises of Kingscombe in occupation of Arthur Traherne, gent, to have and to hold as tenants in common and not as joint tenants according to the custom of the manor Fine 2s.

Surrender and Admittance 20th September 1886. John Lewis of London and the Rev. David Lewis of Briton Ferry, by Thomas Tamplin of Bridgend, solicitor, surrendered for £1180 to them paid by **William Rees** of Graig Ddu Dinas, Glam, innkeeper, one customaryhold messuage, orchard and garden known as Kingscombe House and a piece of land called Crofta Mawr formerly in the occupation of Arthur Traherne in the village and parish of Llanblethian William Rees was admitted to the premises according to the custom of the manor. Sale 9th June 1888 Sale by William Rees to Rev David Bowen, William Thomas and George William Nicholl of a parcel of customaryhold land 60ft x 30 ft. on the road from Llanblethian to Cowbridge. (Site of Sunday school and later church hall).

Surrender 2_{nd} November 1895 William Rees of Kingscombe, late of Graig Ddu Dinas has agreed with **Thomas Thomas** of Wemfawr Farm near Cowbridge, farmer for the sale of premises for £1200 except for the site of Sunday School.
