

Chs07843 Indenture of apprenticeship 1930 – Ken Hutchings with David Brown

THIS INDENTURE made the *Twelfth* day of *March* One thousand nine hundred and thirty BETWEEN DAVID BROWN of Caxton House Cowbridge in the County of Glamorgan Printer of the first part KENNETH MAURICE HUTCHINGS a poor boy of the Town and Parish of Cowbridge aforesaid now aged fifteen years or thereabouts Son of Samuel Hutchings of Number 17 Eastgate Street Cowbridge aforesaid Engine Driver of the second part the said SAMUEL HUTCHINGS of the third part and THE REVERAND GILBERT NWILLIAMS the Vicar or Minister of the said Town and Parish of Cowbridge ARTHUR THOMAS MILLS of High Street Cowbridge aforesaid CHARLES MORGAN DAVIES of Shortlands Westgate Street Cowbridge aforesaid JOHN WILLIAMS of London House Cowbridge aforesaid WYBERT THOMAS of St Crispin Cowbridge aforesaid EVAN THOMAS HOPKIN of The Shield Cowbridge aforesaid and WILLIAM ARTHUR LLOYD PHILLIPS of Broadshord Cowbridge aforesaid (the present Trustees of a Charity for apprenticing poor children of the said Town and Parish of Cowbridge) which said Gilbert Williams, Arthur Thomas Mills, Charles Morgan Davies, John Williams, Wybert Thomas, Evan Thomas Hopkin and William Arthur Lloyd Phillips are hereinafter called the said Trustees and such expression where the context allows includes their and each of their successors in the aforesaid offices respectively of the fourth part WITNESSETH that the said Kenneth Maurice Hutchings of his own free will and with the consent of the said Samuel Hutchings and also with the consent and on the nomination of the said Trustees hereby binds himself apprentice to the said David Brown to learn the art and trade of a Printer from the *Sixth* day of *January* One thousand nine hundred and thirty for the term of SIX YEARS during which time he the said Kenneth Maurice Hutchings will faithfully honestly and diligently serve the said David Brown keep his secrets and readily and cheerfully obey all his lawful and reasonable commands and requirements and will not during the said term buy nor sell without the consent of the said David Brown and will not do or knowingly suffer to be done any damage or injury to the said David Brown and also will not waste the goods of the said David Brown or lend them unlawfully to any person and will not without the leave of the said David Brown absent himself unlawfully from his service but will in all things conduct and acquit himself as an honest and faithful apprentice ought to do AND in consideration of such service and in consideration also of the sum of FIFTEEN POUNDS now paid to the said David Brown by the said Trustees out of moneys arising out of the before named Charity (the receipt whereof the said David Brown do hereby acknowledge) He the said David Brown doth hereby covenant with the said Kenneth Maurice Hutchings and also with the said Trustees that he the said David Brown will teach and instruct or cause to be taught and instructed the said Kenneth Maurice Hutchings in the art and trade of a Printer AND further that he the said David Brown will pay to the said Kenneth Maurice Hutchings the sum of Ten shillings weekly and every week during the first year of the said term the sum of Twelve shillings weekly and every week during the second year of the said term the sum of Fifteen shillings weekly and every week during the third year of the said term the sum of Nineteen shillings weekly and every week during the fourth year of the said term the sum of Twenty Three shillings weekly and every week during the fifth year of the said term and the sum of Twenty Seven shillings weekly and every week during the sixth and last year of the said term AND said Samuel Hutchings for the consideration hereinbefore expressed hereby covenants with the said David Brown and also with the said Trustees that he the said Samuel Hutchings will during the said apprenticeship provide proper and suitable board and lodging and clothing and also physic and surgery in case of sickness or accident for said Kenneth Hutchings PROVIDED ALWAYS and it is hereby agreed and declared that in case of the said Samuel Hutchings neglecting or failing to perform in whole or in part the covenant lastly on his part hereinbefore contained then and in such case it shall be lawful for the said David Brown to apply the wages for the time being payable to the said apprentice under the terms hereinbefore contained in providing such board lodging clothes and other necessaries as hereinbefore provided or such of them as may not be provided by the said Samuel Hutchings.
