### **SECTION 9 - INSURANCE**

Not less than thirty (30) days prior to the move-in date set forth in Section 1 User shall provide the Wisconsin Center District with a certificate of insurance, naming the Wisconsin Center District as additional insured and containing an endorsement requiring seven (7) working days written notice from the insurance carrier prior to cancellation or any change in coverage, scope or amount of the policy or policies.

## **SECTION 10 - PROMOTION**

The term the "Wisconsin Center", "Wisconsin Center Auditorium", "Wisconsin Center Arena" or "Wisconsin Center Convention Hall" shall be referred to when using the Building or the Premises in all print and broadcast materials associated with this Event.

### **SECTION 11- SECURITY**

- A. The User shall be completely responsible for security within exhibit areas, meeting rooms, assigned common areas and other areas of the licensed Premises.
- B. The User shall be solely liable for the acts and conduct of all persons acting for or on behalf of the User and the User agrees to maintain at all times, at its own expense, sufficient security forces to maintain order and to protect persons and property.
- C. Unless permitted in writing by the Wisconsin Center District, the security personnel engaged by User shall be licensed to provide these services by the State of Wisconsin and shall not carry firearms or any other weapons. Any unauthorized person found to possess a weapon on the Wisconsin Center District Premises will be arrested and prosecuted to the fullest extent of the law.
- D. The Wisconsin Center District reserves the right to eject any objectionable person or persons from the Premises and the Building. The User hereby waives any and all rights and claims for damages.
