I have no access at all to www.nafow.org. Until now no one has mentioned it to me at all, except for a communication with Myfanwy in October in which she was inquiring as to what was involved.

If I am to update this site, I'll need to know who the ISP is, payment information, and the site's password. That will allow me access to the site so that it can be changed.

In 1998, I created the WNGGA's main site, and used my ISP at the time (earthlink) to host the site. I have been paying for it via my credit card billing from earthlink since then, with periodic reimbursement (semi-annually or annually) from WNGGA. The intent at that time was that all WNGGA events and contact should occur through www.wngga.org. That has apparently changed since the separate site www.nafow.org was created to promote the Richmond event.
