Dear Sir:

I represent the Welsh National Gymanfa Ganu Association, the membership of which is made up of people of Welsh descent living in the United States and Canada. Each year the Association holds a Gymanfa over the Labor Day weekend in some location in the United States or Canada. The primary event at the Gymanfa is one in which those attending gather at two sessions on Sunday to sing Hymns under the direction of a Musical Director. The Association has published a compilation of hymns from which those to be sung at the Gymanfa are selected. Altho some of the participants bring their own hymnals to the event each year, many rely on purchasing them at the site.

In 1990 the Festival was held in Victoria, B.C. The two sessions devoted to the singing of hymns were scheduled to be held on Sunday, September 2nd. Nelson Llewellyn, the Secretary of the organization, shipped an adequate supply of hymnals destined for Victoria, by UPS in early August 1990. The arrangements were made through Allied Services, Warren, Ohio. Although the hymnals were in Vancouver, B.C. for more than a week before the Gymanfa was held, they were not delivered to Victoria until after the Gymanfa was over. This despite the numerous contacts made with UPS in Vancouver explaining the urgency of the situation.

As a consequence it was necessary to have the hymns to be sung photo-copied and compiled in booklet form for use at the Sunday sessions. This resulted in a cost to the Welsh National Gymanfa Association of \$720.00 U.S.

In view of the foregoing, I request that my client be reimbursed for the \$720.00 it expended.
