Please feel free to contact me any time. I stand ready to assist in any way possible.

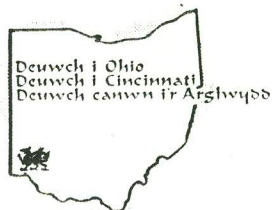
Thank you for the copy of the Hyatt "Conformation Agreement". As we talked by phone it seems standard and of course any advantage you can negotiate will be helpful.
