12:00 p.m. to 2:00 p.m. Sunday

Booths must be staffed at all times!

Take-down: After 2:00 p.m. Sunday and all day Monday if necessary

- Diagram of the Wabasha Room in the Radisson Hotel with booth designations printed on them. (Small black squares indicate pillars.) Your exhibitor badge will be available at Wabasha room door Thursday morning.
- For commercial venders outside of Minnesota:

- An instruction sheet for the tax identification number. Note bracketed information particularly. Minnesota sales tax is 6% except on clothing.

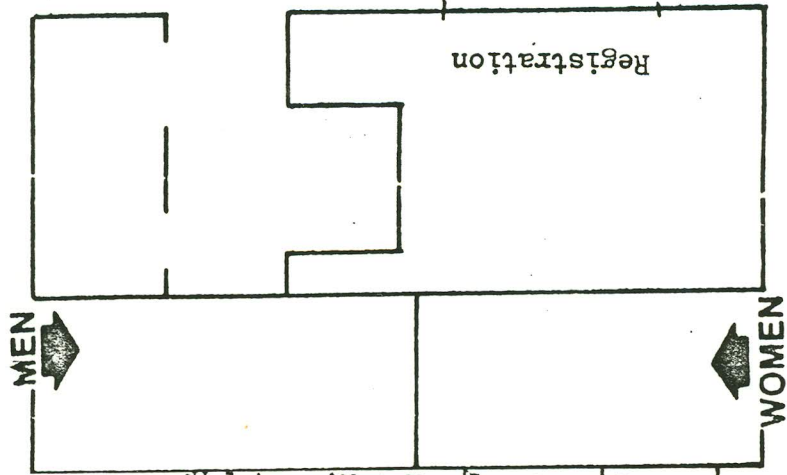
