Dear Nelson:

I'm sorry it has been so long between our telephone conversation and this letter; summer is a busy time anyway and then some unexpected things have come up to cause the delay.

LIABILITY INS
Regarding the subject of liability insurance; in talking with our agent he suggested that a national headquarters would likely have to be established in a specific state and then coverage obtained through an agent licensed in that state. He said there are many companies who carry this kind of policy here in Minnesota so there surely would be in whatever state was chosen as the headquarters. It would, in my opinion, certainly be to everyone's advantage to have the national organization carry the policy and each year's planning committee simply apply for a certificate as proof of the coverage. The cost savings would be substantial since the agent I spoke with "guestimated" the cost for such a policy might run five or six hundred dollars (\$500 or \$600) annually as compared to the \$1,228.00 spent in Wilkes-Barre in 1983 and the \$1,500 shown in the proposed budget of the Columbus Comm. for 1986. My agent said short term policies just cost more than annual ones.

I hope this information will help as you discuss this idea with the Executive Committee.

Things are progressing well here and we are looking forward to Columbus and meeting with you and some of their committee if possible.
