Bob: We haven't worked out in writing yet the details for handling the orders for 1999 National Cassette/CD sales. My suggestion is that since all of the checks are coming here made out to WNGGA, that we deposit those checks as 99 Cassette/CD Income. Then the bill for preparing them I assume will also be coming here which we'll pay out of the 99 Cassette/CD account. Also, we'll pay for the ads which are appearing in the Ninnau and Y Drych from that same account. Then we'll take a certain amount per cassette/CD to cover costs for envelopes, postage, and handling--I am assuming perhaps \$3. Then the balance would be split between Minnesota Gymanfa Ganu Assn and St. David's Society. Then you would not have to carry the accounts in your books and when you close your books on 1999 National, we'll just continue issuing those extra checks from here to Minnesota Gymanfa Ganu and St. David's Society. Does this sound OK to you?

SUBJECT:

Suggested Compromise for Minneapolis Venue

A problem has arisen with the Minneapolis Venue Committee financial situation. When the Board of Trustees accepted the invitation to hold the 1999 National in Minneapolis, it was September, 1996. That was <u>before</u> I was appointed Executive Director. Nothing was indicated in writing at that time or in the following months that \$5 of the Registration was to be paid to National as part of the expenses of the local venue committee. The Minneapolis venue committee <u>did</u> understand that 50 percent of the profits was to go to National.

Thus, the \$5 per paid registration was not included in preliminary budgets or later budget discussions. It came to my attention only as this year's National was being held that \$5 of the registration fee was to be sent to National before the division of profits. This came as a shock to the Committee and has been a bone of contention since notification had not been made earlier to allow modification of the budget to allow for it. (For example, the fee for seminars might have been set at \$8 rather than \$7.)

In the discussions with the Venue Committee, I have acknowledged that it was National's error to not have given notification in writing to avoid this misunderstanding.

The current budget situation for the Minneapolis National is as follows:

The number of paid registrations was 972. At \$5 per person the amount of the payment due National

If that amount is put into the above calculations, the figures would be as follows:

In my discussions with the venue committee, I have tried to work out a compromise that would allow National to collect the \$4,860 (\$5 per paid registration) and at the same time allow the local venue to receive a reasonable profit for all the work they have done in hosting the 1999 National.

Here is a proposal:

Step 1: Local venue would pay \$2 per registration fee (\$1,944) before they close their books. The revised figures from above would be as follows:

Step 2: International Headquarters would handle the sales of the Minneapolis cassette/CD recordings on the following basis:

All income would come to Headquarters

All expenses associated with the production and sale of the recording would be paid by Headquarters. (This would include not only the cost of production but also padded envelopes/boxes in which to mail the items, postage on mailing the items, advertising in Y Drych and Ninnau and through mailings from Headquarters, processing of Minnesota sales taxes, and handling costs to address and mail the mailing pieces.)

Headquarters would retain all profits until the remaining \$3 of the registration fee (\$2,916) and production expenses are recovered. (I am estimating that if the profit is \$7 per cassette and \$10 per CD, we'll recover the \$2,916 when an additional 166 cassettes and 175 CDs are sold. Counting those which have already been sold and the free ones given to volunteers as a token of appreciation for their help during the national, 150 cassettes and 171 CDs are already committed. This will leave about 30 cassettes and 150 CDs for additional distribution of profits.)

SUBJECT: Revenue from Sale of Minneapolis CD's and Cassettes

At the time of the 1999 Minneapolis National Gymanfa Ganu, a misunderstanding was discovered concerning assigning part of the registration fees to expenses incurred by WNGGA Headquarters. An agreement was worked out that WNGGA Headquarters would process all orders for the Minneapolis Cassettes and CD's with income being retained by Headquarters until the partial registration fee amount had been paid. It was further agreed that when that point was reached, any further excess income for sale of the CD's and Cassettes would be divided between the two hosting organizations.

As of December 31, 2002, the partial registration fee amount has been paid and there is an excess of \$261.52. Therefore, enclosed with this memo to each of you is a check for \$130.76 representing your share of the excess. A December 31, Income/Expense/Inventory report spells out the calculations in more detail. If you have any questions, please let me know.
