I trust you are all moved and completely unpacked by now! Yes? Betty and I wish you the very best in your new apartment and hope you will be very happy in the new surroundings.

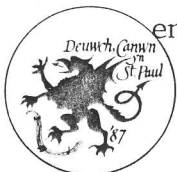
