MINUTES OF

MEETING HELD AT CLEVELAND, OHIO, SEPTEMBER 2, 1934.

The meeting was called to order by President Edward Blythin at 5 o'clock p.m. at the Public Auditorium.

Nineteen Organizations were represented by delegates.

The President spoke briefly as to the purpose of the meeting, the principles for which the Gymanfa Ganu Association stood and the desire for proper organization to perpetuate the ideals and to carry forward the principles of the National Gymanfa Ganu Association. A brief summary was given as to the function of the local committee under whose auspices the Association would be held the following year.

Mr. David Lewis, representing the St. David's Society of Youngstown, Ohio spoke briefly and made a bid for the Gymanfa Ganu for 1935. Mr. W. B. Jones seconded the motion of Mr. Lewis that the Gymanfa Ganu be held in Youngstown next year. The motion was carried.

The following were duly elected National Officers for the ensuing year.

President, Mr. E. B. Williams, Youngstown, Ohio.

Vice President, Dr. John H. Evans, Chicago, Ill.

Treasurer, Mr. W. B. Jones, Pittsburgh, Pa.

Secretary, George Bundy, Warren, Ohio.

Mr. W. B. Jones gave a brief discussion of the financing from year to year and made a motion that 60% of the surplus realized from the Annual National Gymanfa Ganu be retained by the local committee sponsoring for the festival each year and that 40% be given to the National Treasury for the purpose of perpetuating the National Gymanfa Ganu Association. A motion was made and carried to divide the surplus on the above named basis.

A motion by Dr. Evans of Chicago, and same was carried, that each person paying the sum of 25¢ becomes a member of the Association.

A motion was made and carried that each organization may become a member of the Association by contributing the sum of \$1.00 per year.

Motion was made and carried that by-laws of the Association be presented at the next annual meeting and that Mr. David J. Lewis, Youngstown, W. B. Jones of Pittsburgh and Edward Blythin of Cleveland be a committee of three to draw up such by-laws to govern the affairs and conduct of the Association and present the same at our next meeting.

There being no further business coming before the committee the motion to adjourn was in order.
